

**FIRST ADMENDMENT TO BYLAWS OF CAMDEN PLACE 1<sup>ST</sup> ADDITION  
HOMEOWNERS ASSOCIATION, INC.**

This document constitutes the First Amendment to the Bylaws of the Camden Place 1<sup>st</sup> Addition Homeowners Association, Inc. (said Bylaws having been adopted by the Board on October 7, 2010). This Amendment was duly adopted by the affirmative vote of all four (4) members of the Board of said Association as of August 25, 2011. Notice having been duly given to the Board and the following individuals constituting all four (4) Board members affirmatively agreed and consented that, as of August 25, 2011, the Bylaws are amended as set forth herein.

Article Three, Section "e" of said Bylaws (originally adopted October 7, 2010), is hereby amended and replaced in its entirety as follows:

**Article Three**

**Section "e" – Quorum: A majority of the members attending the annual meeting shall constitute a quorum for the transaction of any and all business at any regular or special meeting of the members of the Association.**
