All future water bills will be the responsibility of the HOA. It was anticipated the annual cost would be \$3,000 a year. This has now been added to the 2011 budget. We will ask our HOA members to help keep us informed if there are any broken sprinkler heads in need of replacement. Andrew Culver made a motioned to approve the December 2010 Financials. Michael Cashon seconded the motion. Motion passed by all.
